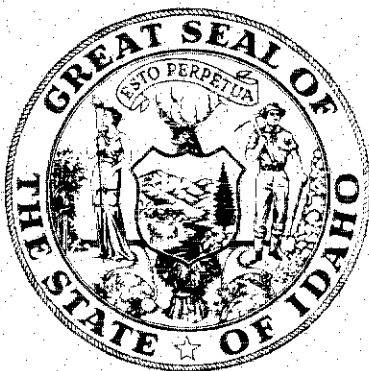

Articles of Amendment of the Articles of Incorporation of  
AUTOPRO, INC., an Idaho corporation, are hereby executed by

1. The name of the corporation is:

2. The amendment to the Articles of Incorporation of  
said corporation is as follows:

RESOLVED, that Article I of the Articles of

hereby amended to read in its entirety as  
follows:

"ARTICLE I. - Name


