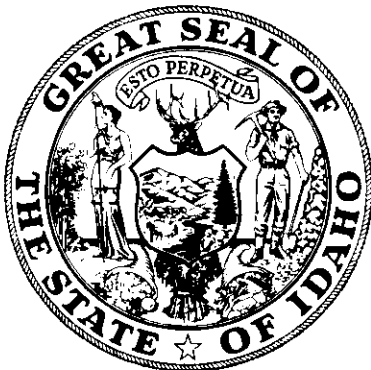

ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION
of
CONSOLIDATED AG OF CURRY, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is CONSOLIDATED
AG OF CURRY, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the undersigned, being all of the original incorporators and all of the members of the initial Board of Directors of the corporation on Wednesday, the 21st day of March, 1984, in the manner prescribed by the Idaho Business Corporation Act:

"ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is two hundred fifty (250) shares, without par value, all of one class. Said capital stock shall be nonassessable.

ARTICLE V.

The provisions denying preemptive rights are: There shall be no preemptive rights to any issued or outstanding corporate shares."


THIRD: The within corporation was initially incorporated as a membership corporation, and has no authorized or outstanding corporate shares; there are no members of the corporation except the original incorporators, all of whom are directors constituting the initial Board of Directors of the corporation.


FOURTH: All original incorporators and all directors constituting the initial Board of Directors of the corporation voted for such amendments, and none of the original incorporators and none of the directors constituting the initial Board of Directors of the corporation voted against such amendments.


