



  - (1) Miles Shoes Meldisco Lakewood, Colorado, Inc. which is a business corporation of the State of Colorado and is the parent corporation and the owner of all of the outstanding shares of each of the corporations listed on Exhibit A annexed hereto, each of which is a business corporation of the State of Idaho and each of which is a subsidiary corporation, hereby merges each of the corporations listed on Exhibit A annexed hereto into Miles Shoes Meldisco Lakewood, Colorado, Inc. pursuant to the provisions of the Idaho Business Corporation Act and pursuant to the provisions of the laws of the jurisdiction of organization of Miles Shoes Meldisco Lakewood, Colorado, Inc.

- (2) The separate existence of each of the corporations listed on Exhibit A annexed hereto shall cease at the effective time and date of the merger pursuant to the provisions of the Idaho Business Corporation Act; and Miles Shoes Meldisco Lakewood, Colorado, Inc. shall continue its existence as the surviving corporation pursuant to the provisions of the laws of the jurisdiction of its organization.
- (3) The issued shares of each of the corporations listed on Exhibit A annexed hereto shall not be converted in any manner, but each said share which is issued as of the effective time and date of the merger shall be surrendered and extinguished.
- (4) The Board of Directors and the proper officers of Miles Shoes Meldisco Lakewood, Colorado, Inc. are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
- 5. Miles Shoes Meldisco Lakewood, Colorado, Inc. is the owner of all of the issued shares of each of the corporations listed on <u>Exhibit A</u> annexed hereto, and Miles Shoes Meldisco Lakewood, Colorado, Inc. waived the mailing of a copy of the Plan of Merger in writing.
  - 6. Shareholder approval was not required.
- 7. The laws of the jurisdiction of organization of Miles Shoes Meldisco Lakewood, Colorado, Inc. permit a merger of an Idaho wholly-owned subsidiary business corporation into a parent business corporation of another jurisdiction and the merger of each of the corporations listed on Exhibit A annexed hereto into Miles Shoes Meldisco Lakewood, Colorado, Inc. is in compliance with the laws of the jurisdiction of organization of Miles Shoes Meldisco Lakewood, Colorado, Inc.
