

DESIGNATION OF AGENT AND ACCEPTANCE OF THE
PROVISIONS OF THE CONSTITUTION OF THE STATE
OF IDAHO.

KNOW ALL MEN BY THESE PRESENTS, That the Lewiston Portland Cement Company, a corporation organized and existing under the Laws of the State of Montana, having filed in the office of the Secretary of the State of Idaho, a duly authenticated copy of its Articles of Incorporation, does hereby in pursuance of the Laws of the State of Idaho, make this certificate, and does hereby designate Nez Perce County, in the State of Idaho, as the county in which the principal place of business of said corporation in said State of Idaho, is and shall be conducted and does hereby designate the City of Lewiston in said Nez Perce County, State of Idaho, as the place in said county where the principal office of the said corporation shall be maintained, and does hereby designate Robert D. Leeper residing at Lewiston, in said county of Nez Perce as the authorized agent of said corporation in said state of Idaho upon whom process issued by authority of or under any law of the State of Idaho may be served as provided by the Constitution and Laws of the said State of Idaho.

And the said Lewiston Portland Cement Company, the corporation aforesaid desiring and intending to conform in all respects to the Constitution and Laws of the said State and to avail itself of the rights, privileges and immunities guaranteed by the Constitution and Laws, does hereby accept the provisions of the Constitution of the State of Idaho for all intents and purposes contemplated by the provisions thereof relating to such acceptance by other than municipal corporations, (Article 11, Section 7, Constitution of Idaho).
