**ARTICLES OF INCORPORATION
OF
ELMORE SHERIFF'S YOUTH FOUNDATION, INC.**

The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

ARTICLE I. NAME.

The name of the Corporation is Elmore Sheriff's Youth Foundation, Inc.

ARTICLE II. NONPROFIT STATUS

The Corporation is a nonprofit corporation.

The purposes for which the Corporation is organized and will be operated are as follows:

- A. The Elmore Sheriff's Youth Foundation will encourage on-going early prevention and intervention activities for at risk youth by developing partnerships between youth, youth service providers, businesses, religious organizations, service clubs, public agencies and individuals to build community assets for youth. The Elmore Sheriff's Youth Foundation will foster relationships that enhance children's ability to reach their potential and become contributing members of society.
- B. Charitable religious, educational, or scientific within the meaning in Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under such Section 501 (c)(3).
- C. To exercise all powers granted by law necessary and proper to carry out the above-stated purposes, including but not limited to the power to accept donations of money, property, whether real or personal, or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

ARTICLE III. INITIAL REGISTERED OFFICE AND AGENT

The location of this Corporation is in the County of Elmore, City of Mountain Home, State of Idaho. The address of the initial registered office is Elmore County Sheriff's Office, 125 South 5th East, Mountain Home, Idaho, 83647, and the name of the initial registered agent is, Laytrede Schultz.

ARTICLE IV. BOARD OF DIRECTORS.

The affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors shall consist of not less than three(3) nor more than twenty-five (25) individuals, each of whom at all times, shall be a member of the Corporation.

ARTICLE VII. VOTING MEMBERS


The Board of Directors will be the voting members of the Corporation.

ARTICLE VIII. DISSOLUTION.

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all assets of the Corporation consistent with the purposes of the Corporation to such organizations as shall at the time qualify as exempt in such manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for such purposes as such organizations, as such court shall determine to be consistent with the purposes of the Corporation.
