ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
SALMON CHAMBER OF COMMERCE, INC.

Pursuant to the provisions of Sections 30-326 and 30-327 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

- I. The name of the corporation is SALMON CHAMBER OF COMMERCE, INC.
- II. The SALMON CHAMBER OF COMMERCE, INC. was issued its certificate of incorporation on March 1, 1977.
- III. The following amendment to Article I of the Articles of Incorporation was adopted by the Board of Directors of the corporation on January 26, 1982, and later adopted by the members of the corporation on March 24, 1982, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE I

NAME

The name of this non-profit corporation is SALMON VALLEY CHAMBER OF COMMERCE, INC.

III. At the meeting of the members of the Salmon Chamber of Commerce, Inc. held on March 24, 1982, as aforesaid, such amendment to the Articles of Incorporation was adopted by unanimous vote of the members. The members present at said meeting constituted a quorum.
