ARTICLES OF INCORPORATION

MOUNTAIN HOME RIFLE AND PISTOL CLUB, INC.

The undersigned, acting as incorporators of a corporation under the "Idaho Non-Profit Corporation Act", Idaho Code Section 30-301 et seq., adopt the following Articles of Incorporation for such corporation.

ARTICLE I

Section 1:

The name of the corporation shall be MOUNTAIN HOME RIFLE AND PISTOL CLUB, INC. (hereinafter designated as "the club").

Section 2:

The club shall be a non-profit corporation.

Section 3:

The period of this corporation's duration shall be perpetual.

ARTICLE II

The purposes and objectives for which this corporation is organized shall be to further the interest and proficiency of its members and to promote firearms safety in the shooting community and such other related activities allowed by law.

ARTICLE III

Section 1:

The street address of the club's initial registered office is 140 West 15th North, Mountain Home, County of Elmore, State of Idaho 83647.

Section 2:

The name of the initial registered agent at the abovereferenced address is Herbert Snoey.

Section 3:

ARTICLE IV

Section 1:

The Board of Directors shall be authorized to levy assessments upon all members or classes of membership alike or in different amounts or proportions or upon a different basis upon

different members or classes of membership, and may exempt some members or classes of membership from assessments. The Board of Directors may also fix the amount thereof from time to time, and make them payable at such times or intervals, and upon such notice, and by such methods as the directors may prescribe. Assessment may be made enforceable by action or by the forfeiture of membership, or both, upon such notice given in writing twenty (20) days before commencement of such action or such forfeiture.

Section 2:

The Board of Directors may authorize the issuance of membership cards which evidence membership rights and voting rights, however, only those memberships designated as "life member" or "regular member" shall have the right to vote. Each life member and each regular member shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the members.

Section 3:

The Board of Directors shall manage the affairs of the club, subject to input and recommendation of the membership. However, the Board of Directors shall have final decision making authority.

Section 4:

The number of individuals comprising the Board of Directors shall be set by the By-Laws, however, there shall be at least three such individuals.

ARTICLE V

Membership shall be voluntary. Qualifications for membership shall be as provided for in the corporation By-Laws.

ARTICLE VI

Section 1:

Elected: The club shall have a president, vice-president, treasurer and secretary, all to be elected by ballot by the voting membership. Vacancies in any of these offices shall be filled as provided in the corporate By-Laws. The duties of these officers shall be as set forth in the By-Laws.

Section 2:

Initial Appointments: The president shall appoint a Parliamentarian.

ARTICLE VII

Section 1:

There shall be as a minimum two regular meetings of the club held each year as provided in the By-Laws. Special meetings may be called by the president upon due notice to the membership.

Section 2:

The number of active members present at a regular business meeting necessary to establish a quorum shall be prescribed in the corporate By-Laws.

ARTICLE VIII

Any proposed amendments to these Articles of Incorporation shall be submitted in writing, signed by three (3) active members, and presented to the Board of Directors. The Board of Directors shall then notify the active members of the club of the proposed amendments at a regular business meeting, and cause them to be voted upon at the following business meeting. A two-thirds majority affirmative vote of the regular members present and voting shall be necessary for adoption of an amendment.

ARTICLE IX

Upon dissolution or disbandment of the club, the Board of Directors will dispose of all funds in excess of its liabilities and property in such a manner as shall be deemed appropriate and consistent with the law applicable to dissolution of non profit corporations.

IN WITNESS HEREOF, for the purpose of forming this corporation under the laws of the state of Idaho, the undersigned incorporators have executed these Articles of Incorporation this day of July 1989.
