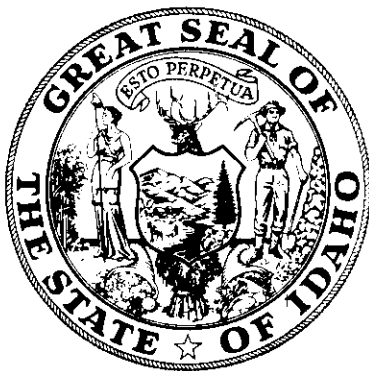


Ronald L. Swafford and Twinkie Swafford, as President

Secretary of State, will be amended as follows:


ARTICLE ONE
