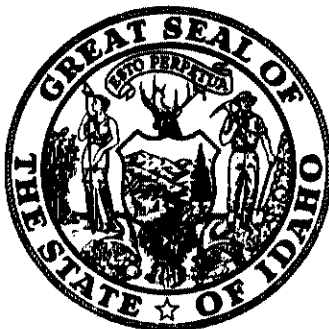
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
OF  
HMW INVESTMENTS, INC.

1. The name of the corporation is: HMW INVESTMENTS, INC.
2. The period of its duration is perpetual.
3. The purpose or purposes for which this corporation is formed are as follows:
  - (a) The investing in and development of real estate projects, including the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act; and
  - (b) Instant to and in furtherance of the above purposes, to invest the corporations funds in real estate, mortgages, stocks, bonds, or any other type of investment permitted by law; and
  - (c) Except as otherwise prohibited by Idaho law, the corporation, in furtherance of its corporate purposes set forth above, shall have all of the powers necessary and proper for the effectuation of any and all legitimate enterprises of the corporation, subject to any limitations provided by the laws of the State of Idaho.
4. It shall have authority to issue Twelve Thousand (12,000) shares, all of one class, @ no par.
