ARTICLES OF INCORPORATION

OF

TREASURE VALLEY FERTILIZER CO., INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME: The name of the corporation is TREASURE VALLEY FERTILIZER CO., INC.

ARTICLE II

DURATION: The period of its duration is perpetual.

ARTICLE III

PURPOSES: The purposes for which the corporation is organized are:

1. To merchandise, sell, offer for sale and distribute at wholesale and retail, agricultural chemicals of all kinds and description whether in bulk, package, bottle or can and to generally deal in agricultural chemicals and related products.

2. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments thereto.

ARTICLE IV

STOCK: The aggregate number of shares which the corporation shall have authority to issue is 10,000. Said stock shall be of one class designated as common stock with a par value of \$1.00 per share.

ARTICLE V

PREEMPTIVE RIGHTS: There are no provisions denying preemptive rights.

2 INTERNAL AFFAIRS: There are no provisions for the
3 regulation of the internal affairs of the corporation.
