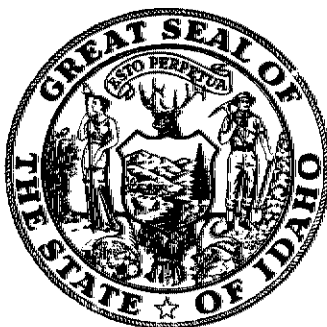

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we the undersigned natural persons of legal age and citizens of the United States, for the purpose of forming a corporation pursuant to the provisions of the Idaho Nonprofit Corporation Act (Title 30, Chapter 3, Idaho Code) do hereby certify as follows:

FIRST

The name of the corporation is

JESUS CHRIST IS GOD, INC.

SECOND

The corporation is to have perpetual existence.

THIRD

The purposes and object for which the corporation is organized:

The purpose of this organization shall be to proclaim and demonstrate the love and compassion of Jesus Christ of Nazareth, for Salvation is found in no one else, for there is no other name under heaven given to men by which we must be saved. We accept Jesus Christ command to Go into all the world and preach the good news to all creation.

The primary purpose of this organization in all things that we do is to spread the gospel of Jesus Christ to the lost and hurting world in which we live, as stated above. Understanding that the harvest of souls is great may the Lord of the harvest use the people associated with this organization as vessels of His love to help gather it in and add to His kingdom such as should be saved. Being guided by the Holy Spirit, to demonstrate the love of Jesus Christ through deeds that help meet the needs of the people in which we have and shall have contact with. Bringing faith, hope, and love into the lives of the people we touch. The purpose also includes the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Nonprofit Corporation Act (Title 30, Idaho Code). Said corporation is organized exclusively for charitable and religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

FOURTH

The corporation will not have members or classes of membership.

EIGHTH

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of Internal Revenue Code, or the corresponding section of any future federal tax code.

NINTH

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
