AARTICLES OF INCORPORATION OF IDAHO PERUVIAN HORSE CLUB, INC.

KNOW ALL MEN BY THESE PRESENT, That we, the undersigned, each being a ~~qualified~~ person of full age and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a corporation not for profit under Title 30 Chapter 3 of the Idaho Non-profit Corporation Act and under the laws of the State of Idaho in general, and we do hereby certify, declare and adopt the following articles of incorporation.

I

The name of this Corporation shall be Idaho Peruvian Horse Club, Inc.

II

The period of existence and duration of the life of this corporation shall be perpetual.

III

The location of the registered office of this corporation shall be Jerome, County of Jerome, State of Idaho, and the address of the registered office of this corporation shall be 28B South, 400 West, Jerome, Idaho 83338. The registered agent shall be Linda Hine.

IV

The objects of this club shall be to unite the persons with an interest in the Peruvian horse, to promote and encourage the breeding and ownership of Peruvian horses, and to do all things necessary which the members or directors of the club shall deem necessary or desirable to accomplish such objectives, within the limitations herein set forth.

This corporation shall not engage in any form of trade or commerce, or carry on any activity which will result in remunerative profit to the members.

Subject to the foregoing limitations and in accordance with the objects hereinabove set forth, the purposes, powers, business and pursuits of this corporation shall be as follows:

To receive gifts and grants of money and property of every kind, and to administer the same as shall be deemed desirable in carrying out the objective of this corporation.

To enter into, make and perform and carry out contracts of every sort and kind with any person, firm, association or corporation, municipality, body politic, country, territory, district, state and government.

To institute, enter into, carry on, assist, promote or participate in financial, commercial, mercantile, industrial and other businesses, works, enterprises, undertakings and operation.

To purchase, subscribe for, or otherwise acquire and own, hold, use, sell, assign transfer, mortgage, pledge, exchange, or otherwise dispose of real and personal

property of every kind and description, including but not limited to shares of stock, bonds, debentures, notes, evidences of indebtedness, and other securities, contracts or obligations, of any corporation or corporations, association or associations, domestic or foreign, and to pay therefore in whole or in part cash or by exchanging therefore stocks, bonds, or other evidences of indebtedness or securities of this or any other corporation, and while the owner or holder of any such real or personal property, stocks, bonds, debentures, notes, evidences of indebtedness or other securities, contracts or obligations, to receive, collect and dispose of the interest, dividends and income arising from such property, and to possess and exercise in respect thereof, all the rights, powers and privileges of ownership, including all voting powers on any stocks so owned.

To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, and other negotiable or transferable instruments.

In the purchase or acquisition of property, business, rights or franchises, or for additional working capital, or for any other object in or about its business or affairs, and without limit as to amount, to incur debt, and to raise, borrow and secure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, debentures, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust or otherwise.

To carry on any other business which may seem to the corporation capable of being conveniently carried on in connection with its business or objective, or calculated directly or indirectly to enhance the value of or render profitable any of the corporation's property or rights.

The said corporation may perform any part of its business outside the State of Idaho, in the other states, in the District of Columbia, territories or possessions, or dependencies of the United States.

To do each and all things set forth herein to the same extent and as fully as natural persons might do or could do in the State of Idaho, and in any other state, county or place.

The foregoing clauses shall be construed as objectives, purposes and powers; and it is hereby expressly provided that any enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objectives or the furtherance of any of the power hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objectives or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

V

In furtherance, and not in limitation of the powers confirmed by statute the board of directors is expressly authorized:

To authorize and cause to execute mortgages and liens upon the real and personal property of this corporation.

This corporation may in its by-laws confer powers upon its directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon them by statute.

## VI

The corporation formed hereby shall have no capital stock, and shall be composed of members rather than shareholders. The conditions and regulations of membership and the rights or other privileges of the classes of members shall be determined and fixed by the by-laws of the corporation. No interest of any member shall be assignable or transferable, and membership in this association shall not be considered as having any monetary value. Any member may be expelled from the corporation upon the conditions, and for the reasons as may be specified in the by-laws.

## VII

The individuals listed below established the IDAHO PERUVIAN HORSE CLUB, INC., a non-profit corporation, organized under the laws of the State of Idaho, and held an election of officers. These same persons being the original charter members of said corporation shall hereby constitute the original Board of Directors of this corporation.
