## TRANSIT HOMES OF AMERICA, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Transit Homes of America, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted by the shareholders of the Corporation on November \_\_\_\_\_\_, 1990, in the manner prescribed by the Idaho Business Corporation Act:

Article TENTH is hereby amended to read as follows:

#### TENTH.

A voluntary sale, lease or exchange of all of the property and assets of the corporation, including its good will and its corporate franchises, may be made by the Board of Directors upon such terms and conditions as it may deem expedient for the best interests of the corporation, but only when such act is authorized by a majority vote of all shareholders. A majority vote is hereby defined as a vote of greater than fifty (50) percent of all shares issued and outstanding.

THIRD: The number of shares of the Corporation outstanding at the time of such adoption was 145,000, and the number of shares entitled to vote thereon was 145,000.

FOURTH: The number of shares voted for such amendment was 87,000, and the number of shares voted against such amendment was zero (0), the number of shares abstaining was 58,000.
