DECREE OF DISSOLUTION

The voluntary application for the dissolution of Keystone Ranch, Inc., an Idaho corporation, coming on regularly this day for hearing and determination and the court finding that on the 8<sup>th</sup> day of April, 1966, in accordance with the order of this court, the said Keystone Ranch, Inc., filed with the Clerk of said court its voluntary application for its dissolution as a corporation; that in accordance with the order of this court the clerk has given notice of said Application for Dissolution and the hearing thereon by publication in the Clearwater Tribune, a newspaper of general circulation, printed and published in the County of Clearwater, which said notice was duly and regularly given as provided by law; that no objections to said Application for Dissolution have at any time been filed herein; and that all allegations and statements in said Application for Dissolution are true and supported by the evidence introduced herein by and on behalf of said corporation; and the court being fully advised in the premises, now, therefore,

IT IS ORDERED, ADJUDGED AND DECREED that the sum of \$7,500<sup>00</sup> be allowed as fees and compensation for Frank V. Barton, the Secretary and Attorney for the said corporation, and he is hereby authorized and directed to pay said sum from the funds of the corporation now in his custody and control, and he is further

authorized and directed to cause the necessary tax returns and tax information to be prepared and submitted to complete the liquidation of the corporation.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that said corporation, Keystone Ranch, Inc., be, and the same is, and is declared to be, dissolved.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the officer, director, and attorney for Keystone Ranch, Inc., namely Frank V. Barton, be, and he is hereby authorized and directed, as trustee of said corporation to wind up the affairs of the corporation and to transfer all of the remaining assets of the corporation to the estate of Alfred Taylor Cram, deceased, and to the estate of June Valeria Cram, deceased, in the proportion of one-half to each of said estates.
