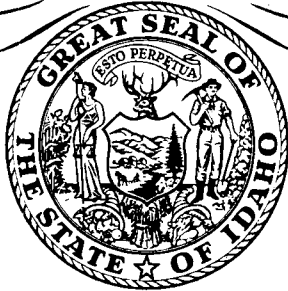

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF IDAHO DOOR AND SUPPLY CO., INC.

The undersigned, being the President and Secretary of Idaho Door and Supply Co., Inc., do hereby certify that the Articles of Incorporation of this corporation have been amended as follows:

I.

Article I is hereby amended to read as follows:

ARTICLE I.

That the name of this corporation shall be:

IDAHO DOOR & SUPPLY CO.

II.

That said amendment was duly adopted by the stockholders of this corporation at a special meeting called and held for that purpose on the 30th day of April, 1965.

III.

That there were 10,000 shares of stock of said corporation issued and outstanding at the time of said special meeting, and all of said stock was entitled to vote on said proposed amendment, and all of said stockholders did vote in favor of said amendment.
