IT IS HEREBY ORDERED that Flat Roof Specialists LLC, an Idaho limited liability company, (hereinafter "the Company") is judicially dissolved;

IT IS HEREBY FURTHER ORDERED that all parties are granted access to the Company books and records during the winding up of the affairs of the Company;

IT IS HEREBY FURTHER ORDERED that Bradley D. Swan of the firm of Presnell Gage, PLLC is appointed as receiver for the Company to control and judicially supervise the winding up of the Company, including, but not limited to, access to all company books, records and assets for purposes of liquidating the assets of the Company and paying its obligations to the fullest extent allowed under Idaho Code § 30-6-702(5);

IT IS HEREBY FURTHER ORDERED that Mr. Swan shall be paid for his services out of the proceeds of the winding up prior to satisfying any other obligations of the Company and shall cause Articles of Dissolution to be filed with the Idaho Secretary of State as soon as is reasonably practicable; and

IT IS HEREBY FURTHER ORDERED that a Preliminary Injunction is entered immediately enjoining the plaintiffs and the defendant from utilizing any of the assets of the Company unless and until the Court orders otherwise, except Mr. Irvine may drive the
