

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho,

And we do hereby certify;

1st. That the name of this corporation is the Soo-Idaho Mining Company, Limited.

2nd. That the purposes for which this corporation is formed are to work, operate, but, sell, lease, locate, acquire, procure, hold and deal in mines, minerals and mining claims of every kind and description within the State of Idaho; to carry on and conduct a general mining, milling and reduction business; to purchase, locate, acquire and hold mill sites, to locate, purchase, acquire, or procure and operate water-rights and water powers for the working or operating of mines, mills or reduction works; to own, bond, buy, sell, lease or locate timber or timber claims for mining or milling purposes; to construct, own and operate electric light and power plants for the purpose of furnishing power and lights for all necessary purposes pertaining to mining; to construct and equip telephone or telegraph lines from any mining or other property, or properties, that the said corporation may be operating, to any points within the State of Idaho, and when so equipped and constructed, to operate said telegraph and telephone lines; to acquire by location or otherwise tunnel sites and to operate the same for mining purposes; to construct, own and operate saw mills, or other machinery for mining purposes; to acquire by location or purchase placer mines and to operate the same; to acquire, by location or otherwise, water-rights and to construct and own water ditches and flumes; to construct, own and operate rail roads, ferries, tramways, or other means of transporting ores, materials or supplies in connection with the general operations of the company; and to do everything consistent, proper and requisite for carrying on the object and purposes aforesaid in their fullest and broadest sense within the state of Idaho.

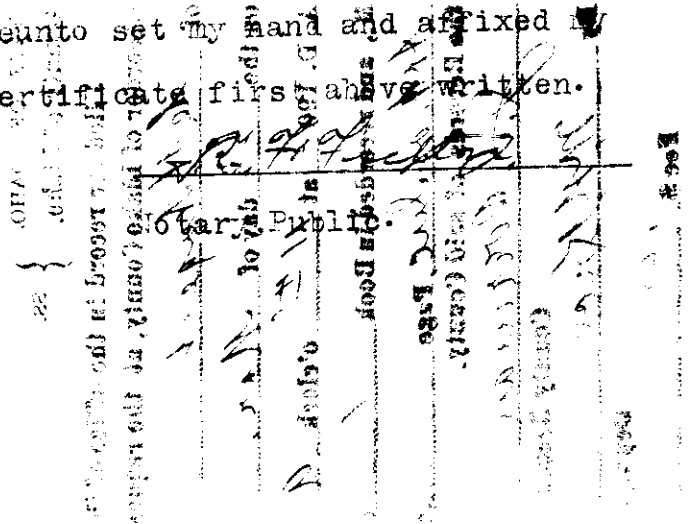
