

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is Cornerstone Capital, Inc. of Boise.

ARTICLE I.

The period of its duration is perpetual.

ARTICLE II.

The corporation is organized for the purpose of conducting and transacting any or all lawful business in the State of Idaho.

ARTICLE III.

The aggregate number of shares which the corporation shall have authority to issue is \$100,000.00 which shares shall have \$1.00 par value.

ARTICLE IV.

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the Bylaws of the corporation as from time to time adopted or amended.

ARTICLE VII.

Each director and officer of the corporation now or hereafter serving as such, shall be indemnified by the corporation against any and all claims and liabilities to which he has or shall become subject by reason of serving or having served as such director or officer, or by reason of any action alleged to have been taken, omitted, or neglected by him as such director or officer; and the corporation shall reimburse each such person for all legal expenses reasonably incurred by him in connection with any such claim or liability, provided, however, that no such person shall be indemnified against, or be reimbursed for any expense incurred in connection with, any claim or liability arising out of:

- i) A financial benefit received by a director to which he is not entitled;
- ii) An intentional infliction of harm on the corporation or the shareholders;
- iii) A violation of section 30-1-833, Idaho Code, or
- iv) An intentional violation of criminal law.

This indemnification is made pursuant to Idaho Code, 30-1-202(2)(d).




