

SECRETARY The undersigned, acting as incorporators of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST: NAME The name of this corporation shall be ORR ENTERPRISES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which this corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
