ARTICLES OF ASSOCIATION

of

Boise Road Runner's Motorcycle Club

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being five natural persons of full age and citizens and bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit cooperative association under Chapter 10, Title 30, Idaho Code ~~Annotated~~, and we do hereby certify:

ARTICLE I

That the name of said corporation shall be:

BOISE ROAD RUNNER'S MOTORCYCLE CLUB, INC.

ARTICLE II

The purposes for which this association is formed are:

- (a) To promote the use of motorcycles for recreational and pleasure purposes by the members of the association and the public generally.
- (b) To cooperate with all law enforcement officers in the enforcement of all motor vehicles and traffic laws, ordinances and regulations.
- (c) To promote the proper use of the highways and to encourage the proper maintenance and construction of the state highways.
- (d) To affiliate or associate with other similar associations or organizations of a state or national kind and such organizations within the State of Idaho.
- (e) To purchase, hold, convey, mortgage and encumber real and personal property and to borrow money with or without securing the same with the property of the association as the purposes of the association may require.
- (f) To organize, promote and advertise safety and educational campaigns in the use of the highways of this state, especially in the use of motor-

cycles and similar vehicles thereon.

- (g) To carry on and promote any undertakings which are calculated directly or indirectly to promote the interests of this association and generally to have, enjoy and exercise all rights, powers and privileges which have now or may hereafter be conferred upon non-profitable cooperative associations organized under the laws of the State of Idaho, and to do all things necessary, suitable, convenient or proper for the accomplishment of the purposes and this to the same extent and as fully as natural persons might or could do.

### ARTICLE III

The term for which this corporation shall exist shall be perpetual.

### ARTICLE IV

The location and post office address of its registered office in this State and its principal place of business shall be at Boise City, Ada County, Idaho

### ARTICLE V

This association is a non-profit sharing membership corporation without capital stock. All persons interested in the purposes of this association, as hereinbefore set forth shall, upon election to membership and the payment of the required fee, be eligible to membership herein. The rights and interests of all members of this association shall be equal. This association shall not issue any capital stock, but shall issue membership certificates to each member thereof, which certificates cannot be assigned so that the transferee can by such transfer become a member of the association, except by regulation of the board of directors and under such regulations as the by-laws may prescribe.

ARTICLE VI

The number of directors of this association shall be five, and the names and post office addresses of the directors who are to set in the capacity of directors until the election of their successors are:
