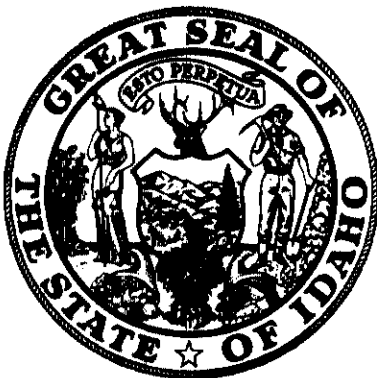

**ARTICLES OF INCORPORATION
OF
MICHAEL J. FLANAGAN, P.A.**

The undersigned, subscriber to these Articles of Incorporation, a natural person over the age of 18 years, competent to contract and a duly licensed attorney to render legal services under the laws of the State of Idaho hereby present these Articles for the formation of a corporation under the Professional Service Corporation Act, Idaho Code § 30-1301, *et seq.* and other laws of the State of Idaho including the General Business Corporation Act, Idaho Code § 30-1-1, *et seq.*

1. **Name.** The name of the corporation is Michael J. Flanagan, P.A.
2. **Nature of Business.** To engage in the practice of law; to appear in a representative capacity as an attorney; to draw papers, pleadings or documents, to perform any act in connection with the legal proceedings before federal, state, or city court, or any subdivision thereof; to advise or direct others as to civil and criminal law; enforce, settle, adjust or compromise defaults, disputes, claims; prepare, draw, assist in the preparation or drawing of any papers relating to the rights of others; and to prepare, draw, procure, assist in preparation or drawing of Affidavits, Deeds, Wills, Conveyances, and Mortgages.
3. **Term of Existence.** The period of the corporation's duration is perpetual.
4. **Capital Stock.** Capital stock of the corporation shall consist of 100 shares of nonassessable, common stock with par value of zero.
5. **Address.** The initial post office address of the principal office of the corporation in the State of Idaho is 350 N. 9th Street, Suite 500, P.O. Box 199, Boise, Idaho, 83702. The Board of Directors may from time to time move the principal office to any other address in the State of Idaho.


