ARTICLES OF INCORPORATION
OF

NELSON SALES & DEVELOPMENT COMPANY, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be Nelson Sales & Development Company, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is 2005 South Roosevelt Street, Boise, Idaho, 83705 and the name of the initial registered agent at such address is Rudy O. Nelson.

IV.

The nature of the business and the object and purpose of this corporation shall be as follows:

To engage in the business of a construction contractor and specifically that of a pavings contractor; and

The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

V.

That the total authorized number of par value shares of this corporation shall be 1,000, each of a par value of \$1.00, and of the aggregate par value of \$1,000.00, which said shares shall be common stock and shall not be subject to assessment.

Any part of the capital stock and any part of the notes, debentures, bonds, or other securities convertible into or carrying options or warrants to purchase stock of this corporation authorized by these Articles of Incorporation or by any amended articles duly filed, may at any time be issued, optioned for sale, and sold or disposed of by this corporation pursuant to a resolution of its Board of Directors to such persons and upon such terms as may to such Board seem proper without first offering such stock or securities or any part thereof to existing shareholders.
