**ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that Dewey Bailey, Shawn Bailey, Donald Bailey and Carolyn Bailey, being of legal age, residents of the State of Idaho and citizens of the United State of America, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho and to that end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify:

ARTICLE I

The name of the corporation shall be **DB TRUCKING, INC.**

ARTICLE II

This corporation is formed for the purposes of hauling and the carrying and transportation of all types of commodities, including sand, gravel and other aggregates as well as including agricultural products and commodities of all types. This corporation shall be further authorized to acquire sand, gravel and other aggregates and sell the same. This corporation shall be authorized to engage in construction work of every type, including buildings, housing, highways and roads, and shall be further be authorized to acquire, purchase and lease trucks, trailers and construction equipment of all types and quantities. This corporation shall have all those powers as set forth under the laws of the State of Idaho, inclusive of those powers set forth in Idaho Code § 30-1-302. The name of the registered agent for DB TRUCKING, INC. is Dewey Bailey, the registered office of this corporation shall be located at 366 Erics Court, Twin Falls, Idaho 83301.

ARTICLE III

Subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

ARTICLE IV

The corporation shall be governed by a Board of Directors. The number of the members of the Board shall be fixed in the by-laws of the corporation, except that such numbers shall not be less than one (1) nor more than five (5). The qualifications, duties, powers, limitations and other factors relevant to the functioning of the Board of

Directors shall be set out in the by-laws of this corporation and shall be subject to the laws of the State of Idaho.

ARTICLE V

The Board of Directors of this corporation shall have the power to repeal and amend the by-laws of this corporation and shall have the power to adopt new by-laws. This power may be exercised by the Board of Directors through a majority vote of that Board. The by-laws so repealed, amended or adopted by the Board of Directors, subject to these Articles and the by-laws of the corporation, shall be subject to reenactment, amendment or repeal by the shareholders of this corporation at their regular meetings or at any meeting specially called for that purpose. A majority of the shareholders of the corporation may exercise the powers of reenactment, amendment, or repeal heretofore set out. The by-laws of this corporation shall regulate the manner of voting for this and other governing actions of the corporation.

ARTICLE VI

The amount of authorized stock of the corporation shall be two hundred (200) shares of stock, with each share having a no par value.

ARTICLE VII

None of the authorized shares of this corporation shall be assessable.
