The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is GOWER INVESTMENT GROUP, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, specifically but not limited to the conduct of a Building Products Investment and Distribution Company.

FOURTH: The aggregate number of shares which the corporation shall have authority to issues is FIVE THOUSAND (5,000) shares of common stock all with no par value.
