1. The Plan of Merger between Blacker Appliance and Furniture of Caldwell, Inc. and Blacker Realty Company is as set forth below:

BLACKER APPLIANCE & FURNITURE OF CALDWELL, INC. AND BLACKER REALTY COMPANY PLAN OF MERGER

The terms of this Plan of Merger are as follows:
