THE UNDERSIGNED, acting as incorporator of a Corporation under the laws of the State of Idaho, adopts the following Articles of Incorporation for such corporation and certifies that:

FIRST

The name of this Corporation shall be Mountain West Surveys, Inc.

SECOND

This Corporation is a common stock corporation.

THIRD

The period of duration is perpetual.

FOURTH

The purpose of the formation of this Corporation is for the sole and specific purpose of rendering land surveying and related services and for the transaction of any or all other lawful business.

FIFTH

The capital stock of this Corporation consists of 10,000 shares of common stock, having a par value of Ten and No/100 (\$10.00) Dollars per share and an aggregate par value of \$100,000.00; each share shall be non-assessable when fully paid for.

The capital stock of this Corporation shall not be divided into classes, but shall consist of one class only, that being common stock; each share of stock shall be entitled to one vote in all matters wherein the shareholders of this Corporation shall be entitled to vote, and each share shall in all respects be equal to every other share.

The capital stock shall be transferred only in accordance with such rules and regulations as are established by the Bylaws of the Corporation, and all restrictions relative to the transfer of shares of stock of this Corporation shall be noted on the stock certificate issued by this Corporation.

SIXTH

The location of the initial registered office of this Corporation is 31 East Main Street, Weiser, Idaho 83672 and the name of its initial registered agent at such address is Kenneth Lane Thomason. The mailing address for future reports is P.O. Box 547, Weiser, Idaho 83672.

The right and power to adopt, repeal, alter, rescind and amend the Bylaws of this Corporation and to adopt new Bylaws is hereby expressly conferred upon the Board of Directors of this Corporation as provided by Title 30 of Idaho Code.

EIGHTH


