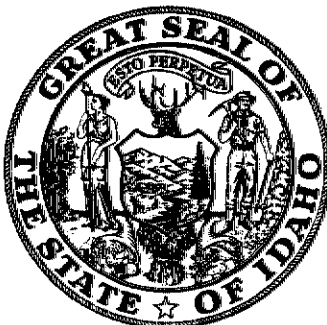

Articles of Incorporation
of
Houses Duplexes & More, inc.

Article I. The name of this corporation shall be Houses Duplexes & More, inc. This corporation is hereby formed under and in accordance with the Idaho Business Corporation Act.

Article II. The term or period of duration of this corporation shall be perpetual.

Article III. This corporation may enter into any transaction not otherwise prohibited under the Idaho Business Corporation Act.

Article IV. This Corporation is authorized to issue one class of common shares. Such shares are to have a par value of \$1. This corporation shall have the authority to issue an aggregate number of shares not to exceed 100,000.

Article V. Shareholders have no pre-emptive rights to acquire either unissued or treasury shares. These Articles do not restrict the ability or manner in which shareholders may execute otherwise legal transfers of shares of the corporation.

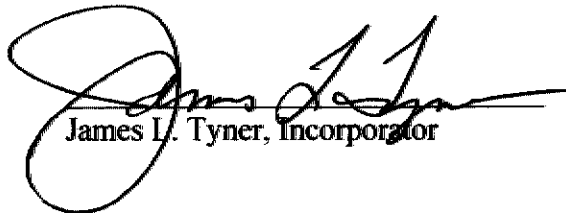
