I, ROBI L. MANLEY-CROMMETT, the undersigned person of the age of eighteen years or more, as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation is HOMEBOODIES, INC.

ARTICLE II

DURATION

The corporation has perpetual existence.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Title 30 of the Idaho Code, as amended.

ARTICLE IV

REGISTERED AGENT AND OFFICE

The address of the registered office of the corporation is 2017 N. Lincoln Street, Post Falls, Idaho 83854, and the name of the registered agent at such address is ROBI L. MANLEY-CROMMETT.

## ARTICLE V

### STOCK

5.1 Authorized Shares. The total authorized number of shares of the corporation is Five Thousand (5,000) shares, all of such shares to be without par value.

5.2 Pre-emptive Rights. Shareholders of this corporation have no pre-emptive rights to acquire additional shares issued by the corporation.

5.3 Cumulative Voting. At each election for directors, every shareholder entitled to vote at such election has the right to vote in person or by proxy the number of shares of stock held by him or her for as many persons as there are directors to be elected. No cumulative voting for directors shall be permitted.

## ARTICLE VI

### DIRECTORS

6.1 Number. The number of directors of this corporation shall be fixed by the bylaws and may be increased or decreased from time to time in the manner specified therein. The initial Board of Directors shall consist of one (1) director, whose name and address is:

The first director shall serve until the first annual meeting of shareholders and until her successor is elected and qualified.

6.2 Duties and Powers. The Board of Directors shall oversee the internal affairs of the corporation and shall have the power to adopt, amend or repeal the bylaws of this corporation, subject to the power of the shareholders to amend or repeal such bylaws. Such other and further duties and powers shall be set out in the corporate Bylaws.

6.3 Director Liability. A director shall have no liability to the corporation for monetary damages for conduct as a director, except for acts or omissions that involve intentional misconduct by

the director, or a knowing violation of law by the director, or for any transaction from which the director will personally receive a benefit in money, property or services to which the director is not legally entitled. If the Idaho Business Corporation Act is hereafter amended to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director shall be eliminated or limited to the full extent permitted by the Idaho Business Corporation Act, as so amended. Any repeal or modification of this Article shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification for or with respect to an act or omission of such director occurring prior to such repeal or modification.



The undersigned incorporator has signed these Articles of Incorporation as duplicate originals on February 25, 2005, under penalty of perjury.


