ARTICLES OF DISSOLUTION OF A NON-PROFIT CORPORATION MULLAN TELEVISION COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS: That EDITH V. NEWELL, Secretary of the corporation and the undersigned herein, does hereby sign and acknowledge the following Articles of Dissolution for a non-profit corporation, in duplicate originals, and state as follows:

ARTICLE I.

At the time of incorporation, the name of the non-profit corporation was MULLAN TELEVISION COMPANY. Since that time MULLAN TELEVISION COMPANY has done business as the MULLAN TELEVISION COMPANY, INC. Its mailing address is P.O. Box 615, Mullan, Idaho, 83846. The non-profit corporation was incorporated on the 8th day of July 1954.

ARTICLE II.

The non-profit corporation has not issued any corporate shares during its existence. However, the corporation offered memberships to those individuals utilizing the television services provided by the corporation. The memberships were never intended, nor were they granted in lieu of shares of stock in the corporation.

ARTICLE III.

The notice of dissolution of the corporation to the membership and creditors has been given as required by Idaho Code \$30-1-141.

ARTICLE IV.

All debts, obligations and liabilities of the non-profit corporation have been paid, discharged, or adequate provisions have been made for payment and no debt remains unpaid.

ARTICLE V.

All remaining property and net assets of the corporation have been distributed in accordance with the distribution provision in the Corporate Bylaws and Idaho State Law.

ARTICLE VI.

There are no suits pending against the corporation in any court of competent jurisdiction.

ARTICLE VII.

Dissolution was authorized on March 3, 2005, by Resolution No: 001 and as required by law and the articles of incorporation and/or bylaws of the corporation, at a regularly conducted annual meeting of the corporation. The membership present at the meeting voted on said resolution by approval by a majority vote of the members then present at the annual meeting.

The total number of members entitled to vote is 201. The total number of members present at the annual meeting was 36.

ARTICLES OF DISSOLUTION - 2

All 201 members received notice by mail of the annual meeting along with a ballot for purposes of voting absentee. Notice of the annual meeting was also published in the local newspaper of general circulation.

The number of votes cast by the members entitled to vote on dissolving the corporation was as follows: 33 (FOR) 3 (AGAINST)

165 (NO RESPONSE RECEIVED).

The total number of votes cast FOR dissolution by the members was a majority of the members present and therefore was sufficient for approval to dissolve the corporation and was in accordance with the articles of incorporation and bylaws of the corporation.

ARTICLE VIII.
