

ARTICLES OF INCORPORATION

We the undersigned natural persons of the age of 21 years or more, acting as Incorporators of a corporation under the Idaho Business Corporation Act adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is Contract Data Services, Inc., and its duration shall be perpetual.

ARTICLE II - PURPOSE

The purpose for which this Corporation is organized is to have unlimited power to engage in and to do any lawful act concerning any and all lawful business for which corporations may be organized under the laws of the State of Idaho to primarily conduct the business of supplying a service.

ARTICLE III - SHARES

The aggregate number of shares which the Corporation shall have authority to issue is one thousand (1000) shares of voting common stock, having a par value of \$1.00 per share or a total of \$1000.00. Each share with voting rights shall entitle the shareholder to one vote. All stock of the corporation shall be nonassessable.

A shareholder shall not be liable to the corporation or to its creditors for any debts or obligations of the corporation.

The corporation shall have the right to purchase, take, receive, or otherwise acquire, own, pledge, transfer or otherwise dispose of its own shares to the maximum extent permitted by law of the State of Idaho.

#### **ARTICLE IV - COMMENCEMENT OF BUSINESS**

The corporation shall not commence business until consideration of the value of at least ONE HUNDRED DOLLARS (100.00) shall be received by it as consideration, in the form of cash or property, for the issuance of its shares.

#### **ARTICLE V - INTERNAL AFFAIRS**

The regulation of the internal affairs of the corporation shall be governed by the By-Laws.

#### **ARTICLE VI - REGISTERED OFFICE**

The initial registered office within the State of Idaho shall be 617 East State Street, Eagle, ID 83616 and the registered agent at such address shall be Denny Pomerleau.

#### **ARTICLE VII - DIRECTORS**

The members of the Governing Board shall be Known as Directors and the Number thereof shall be fixed by the By-Laws of this Corporation. The initial Board of Directors who are to serve until the first annual meeting of the shareholders, or until their successors are elected and shall qualify are as follows:


## ARTICLE VIII
