### CERTIFICATE OF INCORPORATION

I, JAS H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**COMMUNITY BIBLE CHURCH OF BLACKFOOT, IDAHO, INC.**

was filed in the office of the Secretary of State on the **17th** day of **September** A. D. One Thousand Nine Hundred **Fifty-seven** and is duly recorded on Film No. **100** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Blackfoot** in the County of **Bingham** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
of  
COMMUNITY BIBLE CHURCH OF BLACKFOOT, IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all adult citizens of the United States, residents of the State of Idaho, and members of Community Bible Church of Blackfoot, Idaho, and pecuniary profit not being an object of organization, have this day voluntarily associated ourselves together for the purpose of forming a non-profit religious corporation under the provisions of Chapter 11 of Title 30 of the Idaho Code, and we do hereby certify:

I

That the name of this corporation is Community Bible Church of Blackfoot, Idaho, Inc.

II

That the purposes for which this corporation is formed are:

(a) To engage in the spreading and teaching of the Gospel of Christ, the winning of souls, ministering to the spiritual needs of the community, and functioning generally as a religious church body;

(b) To acquire, lease, purchase, hold, and use real and personal property necessary for the business convenience and objects of the Association, to sell, encumber, lease and otherwise dispose of such property, to accept gifts, dues, legacies and bequests under conditions provided in the By-Laws of the corporation; and

(c) To do all other things that may be necessary for the complete enjoyment of the privileges, rights and benefits of this Association as a religious church organization.

III

The existence of this corporation shall be perpetual.

IV

The location and Post Office address of the registered office of this corporation in the State of Idaho is at Blackfoot, Bingham County, Idaho.

V

This corporation shall be without capital stock or shares, but it shall have members whose membership shall be equal and qualifications, conditions and government of members shall be as provided in the By-Laws of the corporation.

VI

That on the 7th day of April, 1957, a meeting of the members of Community Bible Church of Blackfoot, Idaho, was held at the Parish Hall in Blackfoot, Bingham County, Idaho, for the purpose of considering organization of a non-profit religious corporation and elect directors, at which meeting there were present the undersigned persons and ten other adult members, who unanimously adopted the name of Community Bible Church of Blackfoot, Idaho, Inc., as the name of this corporation, and elected Charles Lowe, William Tacklind and Glen D. Brooke as directors for the first year, all members present voting in the affirmative; that at said meeting the following officers were elected to serve until the first annual meeting: Charles Lowe, Chairman, William Tacklind, Vice-Chairman, and Glen D. Brooke, Secretary and Treasurer of the corporation. Charles Lowe acted as Chairman of said meeting and Glen D. Brooke acted as Secretary thereof; that prior to said meeting, notice thereof was given by publication of said notice in The Daily Bulletin, of Blackfoot, Bingham County, Idaho, for a period of two successive weeks.

That the number of directors of this corporation shall be three (3) and the names and residences of those who were appointed to serve for the first year are as follows:
