

ARTICLES OF INCORPORATION .

KNOW ALL MEN, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the state of Idaho, and in pursuance of the purposes for which we have been elected, as herein set forth, a religious corporation to be known as the BURLEY METHODIST EPISCOPAL CHURCH.

We certify, that the objects for which this corporation is formed are: to establish a church in the town of Burley, Cassia County, Idaho, and in connection therewith suitable and customary ^{organizations} ~~ordinances~~, for the purpose of public worship and religious training, according to the rules and discipline of the Methodist Episcopal Church of the United States of America, to take charge of the church building, estate, and property, and the affairs of the temporalities thereof ;

That the principle place of business of this corporation shall be in the town of Burley, Cassia County, state of Idaho;

That the term of the ⁱⁿcorporation shall be fifty years ;

That the number of trustees who shall have the management of its affairs aforesaid shall be ^{five} ~~be~~ and the names of the trustees elected for the first year are, as follows ;

That the said trustees were duly elected at a meeting of the members of said church, duly convened and held at Burley, Cassia County, Idaho, for the purpose, among other things, to elect trustees to take charge and management of its property, temporalities, and affairs, and to form this corporation.

That the majority of said members were then and there present, and voted at such election, for the above name trustees, as is more particularly set forth in the certificate and verification by the officers who conducted the election, hereto annexed and made a part of these articles.
