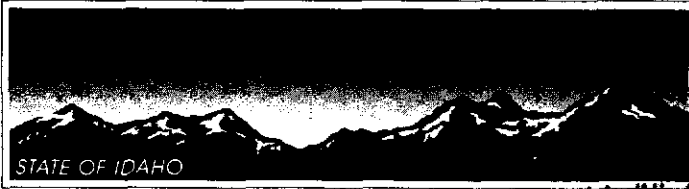


Dear Corporations Clerk:
