## **AMENDMENTS**

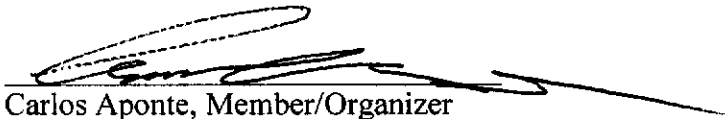
The Certificate of Organization shall be amended from time to time as required by Idaho Law.
