ARTICLES OF INCORPORATION

NORTH IDAHO AMATEUR REPEATER ASSOCIATION, INCORPORATED

- The undersigned, a majority of whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law Of Idaho, do hereby certify:
- 1. The name of the Corporation shall be, North Idaho Amateur Repeater Association, Incorporated.
- 2. Said association is organized exclusively for charitable, scientific, literary, or educational purposes, that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future U. S. Internal Revenue Law).
- 3. The period of duration of this association shall be perpetual.
- 4. The purpose for which this association was organized is to provide public service to the community through ARES and emergency service to the Kootenai County Civil Defense Office through the RACES program.

To establish a regional repeater at Idaho Mica Peak on Two Meters, and maintain said repeater for open use of properly licensed users and visitors to the community around Coeur d'Alene.

To help establish and maintain a network of links to other Two Meter repeaters in the 4 northern counties of Idaho, with the mutual cooperation of the repeater owners in these areas.

- 8. No part of the net earnings of the association shall inure to the benefit of, or be distributable to, its Board of Directors, or other private persons, except that the association shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Two hereof. No substantial part of the activities of the association shall be the carrying on of propoganda, or otherwise attempting to influence legislation, and the association shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the association shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from

federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future U. S. Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future U. S. Internal Revenue Law).

9. Upon the dissolution of the association, the Board of Directors, shall, after paying or making provisions for the payment of all the liabilities of the association, dispose of all the assets of the association exclusively for the purposes of the association in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes, as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future U. S. Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the association is then located, exclusively for such purposes to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
