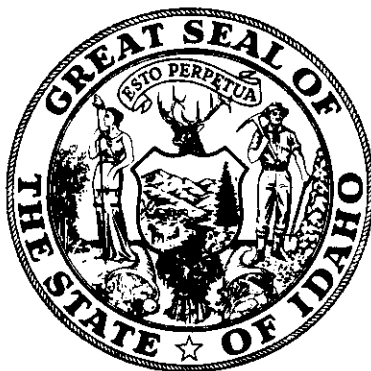

ARTICLES OF INCORPORATION

OF

SECRETARY OF
STATE

PROFESSIONAL TRANSPORTATION SERVICES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Professional Transportation Services, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

(a) To engage in the furnishing of transportation services to shippers and carriers, to advise and consult on traffic management of entities engaged in furnishing transportation and utilizing the services of a transportation entity, to broker general commodities, to consult on general transportation problems, to engage in freight forwarding, to audit freight bills, to assist transportation entities in obtaining necessary permits and licenses, and to consult on transportation problems with shippers and carriers.

(b) To engage in the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 2,500 shares at a par value of \$10.00 per share.

FIFTH: The address of the initial registered office of the corporation is 3303 Cherry Lane, P. O. Box 897, Boise, Idaho 83701, and the name of its initial registered agent at such address is Edgar O. Walton.

SIXTH: The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
