That we, the undersigned, each and all being natural citizens of full age have this day and do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

ARTICLE I.

The name of this corporation shall be **NORTH VALLEY VETERINARY CLINIC, P.A.**

ARTICLE II.

The purposes and objects for which this corporation is formed are:

1. To generally engage, do and perform all types of veterinary services and other services related thereto as authorized pursuant to the provisions of the Idaho Business Corporation Act and the Professional Service Corporation Act.

ARTICLE III.

This corporation shall have a perpetual existence.

ARTICLE IV.

The total number of shares which the corporation is authorized to issue is One hundred thousand (100,000). The aggregate par value of such shares is One million dollars (\$1,000,000.00) and the par value of each share is Ten dollars (\$10.00).

ARTICLE V.

There are no provisions granting or denying preemptive rights. However, the corporation may not issue any capital stock to anyone other than an individual duly licensed to practice veterinary medicine in the State of Idaho.

All stockholders and incorporators herein agree that they shall be governed by the Professional Service Corporation Act of Idaho.

ARTICLE VI.

The address of the initial registered office of the corporation is two and one-half south, Highway 46, Gooding, Idaho, 83330 and the name of its initial registered agent at such address is J. Rand Bergstrom.

The mailing address of the registered office and the registered agent is P.O. Box 386, Gooding, Idaho, 83330.

#### ARTICLE VII.

The number of directors constituting the intitial Board of Directors of the corporation is two (2) and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders, or until their successors are elected and shall qualify, are:


