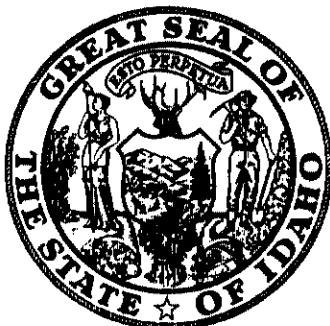
### CERTIFICATE OF AMENDMENT OF

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF IDAHO FALLS RECOVERY CENTER, INC.

Pursuant to the provisions of §§30-326 and 30-327 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is IDAHO FALLS RECOVERY CENTER, INC.
2. There were no members of the corporation as of the date of adoption of these amendments to the articles of incorporation. The following amendments were adopted by a majority vote of the board of directors at a meeting of the board held on October 6, 1992 in a manner prescribed by the Idaho Nonprofit Corporation Act:

The articles of incorporation filed with the Idaho Secretary of State on September 21, 1992, are amended by deleting section 5.1 sub-item class 4 and substituting the following new section 5.1 sub-item class 4:

Class 4: The members of the medical staff of the Idaho Falls Recovery Center, Inc., shall be the members of this class. They shall be entitled to elect 2 persons to the board of directors of the Idaho Falls Recovery Center, Inc. One of the persons elected by this class to serve on the board shall be a member of this class but not a member of classes 2 or 3. The other person shall not be a member of this class or any other class.

The articles of incorporation filed with the Idaho Secretary of State on September 21, 1992 are further amended by deleting the introductory sentences to section 6 and substituting the following new section 6 introductory sentences:

The affairs of the corporation shall be managed by its board of directors. The board of directors shall consist of 5 individuals. No member of the board of directors of the Idaho Falls Surgical Center, Inc., or of the executive committee of Medical Facilities Company, a partnership, shall be eligible to serve on the board of directors of this corporation. The board of directors has the overall responsibility and authority for the operation and performance of the corporation. These requirements include, but are not limited to, the following:
