The director of this Corporation shall not be personally liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director, unless said director has breached or failed to perform the duties of the director's office in compliance with the Idaho Business Corporation Act, and unless said breach or failure to perform constitutes negligence, willful misconduct or recklessness on behalf of said director as set forth with the Idaho Business Corporation Act.
- 8. Pursuant to the Idaho Business Corporation Act, the Corporation shall indemnify any director, officer, or employee, or former director, officer, or employee of the Corporation against expenses actually and necessarily incurred by said person in connectionwith the defense of any action, suit, or proceeding in which said person is made a party by reason of being or having been such director, officer, or employee, except in relation to matters as to which said person did not meet the requisite standard of conduct set forth in said statute.
