

ARTICLES OF INCORPORATION FOR CABINET MOUNTAINS WATER, INC.

We, the undersigned residents of the State of Idaho, being eighteen years or more of age, do hereby associate ourselves together for the purpose of forming a non-profit corporation under the statutes of the State of Idaho.

ARTICLE ONE

NAME

The name of the corporation shall be CABINET MOUNTAINS WATER, INC., and its principal business office shall be 225 Main, P.O. Box 918, Bonners Ferry, County of Boundary, State of Idaho.

ARTICLE TWO

DURATION

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE THREE

PURPOSE CLAUSE

The business and purpose of this corporation shall be the procurement and distribution of domestic water to its members and any lawful purpose and activity associated therewith.

ARTICLE FOUR

NONSTOCK CORPORATION

1. ARTICLES OF INCORPORATION

The coporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof. Membership shall be indicated by membership certificates.

ARTICLE V.

The business of the Corporation shall be managed and conducted by a Board of Directors of not less than one (5) and not more than that which is allowed in the By-Laws. The Boards of Directors shall be elected in the manner set forth in the By-Laws.

In addition to the powers and authority granted to the Directors in these Articles of Incorporation, and in addition to the powers and authority expressly conferred on them by statute, the Board of Directors of the Corporation shall have such additional powers and authority, not inconsistent with law, as may be set forth in the By-Laws.

ARTICLE VI.

The corporation reserves the right to amend, add to, or repeal any provision contained in these Articles of Incorporation, in the manner consistent with law and in conformity with the provisions set forth by the By-Laws.

ARTICLE VII.

In furtherance and not in limitation of the powers conferred by the laws of the State of Idaho, the Board of Directors is expressly authorized to frame and adopt any such By-Laws for the corporation as are not inconsistent

Any By-Laws so adopted by the Board of Directors may be amended or repealed by vote of holders or record of a majority of the corporation's membership certificates at any regular membership meeting or at any special membership meeting called for that purpose.

ARTICLE VIII.

ARTICLE IX.
