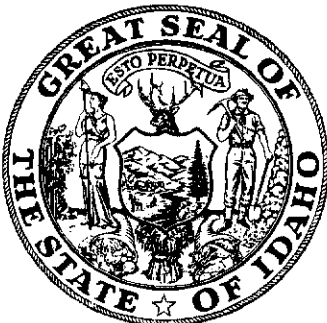

The Articles of Incorporation are hereby amended as follows:

A. The introductory paragraph of the Articles of Incorporation is hereby deleted.

B. Paragaraph a. of the Articles of Incorporation is hereby deleted and replaced by the following:

a. The purpose for which the corporation is formed is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

C. Paragraph b. of the Articles of Incorporation is hereby deleted and replaced by the following:

b. The period of duration for this corporation shall be perpetual.

D. Paragraph c. of the Articles of Incorporation is hereby deleted and replaced by the following:

c. The name of the registered agent for the corporation is Larry J. Hill and the address of the registered office is 435 W. Center, P.O. Box 1447, Pocatello, Idaho 83204.

The foregoing amendments were adopted on May 2, 1996 by the written consent of all the shareholders pursuant to Idaho Code §§ 30-1-59 and 30-1-145.

The number of shares outstanding and the number of shares entitled to vote thereon is 18,941.

All of the shares voted for the amendments as set forth in these Articles of Amendment. There were no shares that voted against the amendment.
