MASON, the President and Secretary, respectively, of INTERMOUNTAIN SOAP & CHEMICAL COMPANY, INC. an Idaho corporation with its principal place of business at Nampa, Idaho, do hereby certify that at a meeting of the shareholders of said corporation duly called and held at the corporate offices in Nampa, Idaho, on October 16, 1974, at the hour of five thirty o'clock p.m. of said day, at which meeting the holders of more than two-thirds (2/3) of the capital stock of said corporation were present in person or by proxy, the following resolutions were duly adopted by more than two-thirds (2/3) vote of all outstanding stock of said corporation to wit:-

RESOLUTION

RESOLVED, That the corporation amend Article V of its Articles of Incorporation to provide for an increase in capitalization by amending Article V to read as follows:

"V

"The total authorized number of shares which may be issued by this corporation is Two Thousand Five Hundred (2,500) shares of common stock with a par value of One Hundred Dollars (\$100) per share".

BE IT FURTHER RESOLVED, That the corporate officers file a certificate of Amendment to the Articles of Incorporation with the Secretary of State of the State of Idaho authorizing said increase in the capital stock of this corporation.
