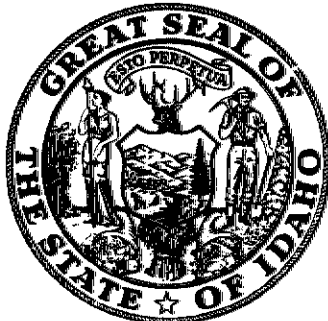

ARTICLES OF INCORPORATION
OF
AMERICAN RIDGE FARMS, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is AMERICAN RIDGE FARMS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to engage in farming operations and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The shares of stock to be issued by the corporation shall consist of one class only, and the aggregate number of shares which the corporation shall be authorized to issue shall be 5,000 shares of stock, each having a par value of \$100.00 per share. All shares of stock shall have the same rights in such corporation and shall be nonassessable when paid in full.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: None.




