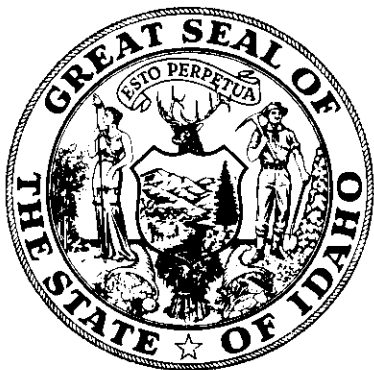

ARTICLES OF AMENDMENT

IDAHO RAIL ORGANIZING NETWORK, LIMITED

The undersigned, a majority of the directors of IDAHO RAIL ORGANIZING NETWORK, LIMITED, set forth the following articles of amendment:

1. The name of the corporation is IDAHO RAIL ORGANIZING NETWORK, LIMITED.
2. That the corporation is in the organizational stage and there are no members of the corporation at present.
3. That a meeting of a majority of the directors of the corporation was held on the 23rd day of ~~May~~ ^{June}, 1980.
4. That at said meeting all of the members of the board of directors that were present voted unanimously to alter and amend ARTICLE III of the original Articles of Incorporation to read as follows:

"ARTICLE III

The purposes for which the nonprofit corporation is organized are: To promote, organize and plan the use of public transportation of persons and freight; to develop and utilize present and future means and modes of transportation for the general benefit of the public, and to do all lawful acts and things incidental thereto; to research and plan such transportation and related facilities and to act as consultants and/or agents for other nonprofit organizations, private or public, as described in Section 501(C)(3) of the Internal Revenue Code of 1954, in connection with such transportation."
