The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is <u>AKRO INVESTMENT SERVICE</u>, INC. (hereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

- 1. To engage in Financial Analysis & Investments ___, and
- To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.
