CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

INTERLOCK, INC.

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Seventeenth** day of **January**, **19 66**, original articles of amendment, as provided by Section **s 30-146, 30-147 and 30-148, Idaho Code**, increasing authorized capital stock from \$25,000.00 to \$100,000.00, divided into 2500 shares common stock @ par value of \$10.00 per share, and 6,000 shares common stock @ par value of \$12.50 per share,

and that the said articles of amendment contain the statement of facts required by law, and are recorded on **Film No. microfilm** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

CERTIFICATE OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
INTERLOCK, INC.

TWIN FALLS, IDAHO, DECEMBER FIVE, 1960:

That the undersigned, Mike L. Wilson, President, and
Alaine K. Timmell, Secretary, of Interlock, Inc., an Idaho cor-
poration, with its principal place of business located at Twin
Falls, Idaho, do hereby certify:

That a meeting of the Board of Directors of Interlock,
Inc., was held on December 5, 1960, at the offices of the corpora-
tion in Twin Falls, Idaho, all Directors being present;

That at said meeting it was duly resolved that the total
number of shares of Interlock, Inc., be increased by 6,000 shares
of a par value of \$12.50 each for an additional capital authoriza-
tion of \$75,000.00;

That the capital authorization for said corporation
previously authorized by the Honorable Arnold Williams, Secretary
of State of the State of Idaho, was \$25,000.00 divided into
2,500 shares of a par value of \$10.00 each;

That pursuant to the requirements of Section 30-138(4)
and 30-146, Idaho Code, said amendment was duly approved and
adopted by a majority of the existing shareholders of Interlock,
Inc.;

That with said amendment of Article V of the Articles
of Incorporation of Interlock, Inc., dealing with capital stock
authorization, said corporation shall have a total capital author-
ization of \$100,000.00 divided into 2,500 shares of a par value
of \$10.00 each and 6,000 shares of a par value of \$12.50 each;

That all of said stock shall be of one class of common
stock, to-wit, non-assessable and voting and each share shall be
entitled to one vote.

RESOLVED, Therefore, that the following amended Article of Incorporation be and the same is hereby adopted to supersede and take the place of the existing Article of Incorporation designated Article V.

"AMENDED ARTICLE OF INCORPORATION

ARTICLE V.

That the amount of the authorized stock of said corporation shall be \$100,000.00, divided into 2,500 shares of common stock, of the par value of \$10.00 per share, and 6,000 shares of common stock, of the par value of \$12.50 per share. All such common stock of this corporation shall be non-assessable and voting, each such share, regardless of par value, to represent one vote."

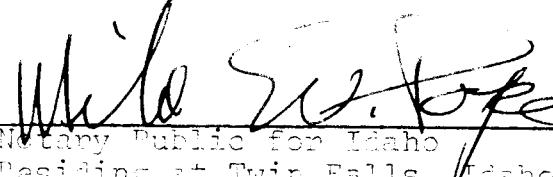
