I am the attorney for the Idaho Board of Licensure of Professional Engineers and Professional Land Surveyors (Board). I write to respond to your letter of June 24, 2019, wherein you indicate that your business, STS Engineering Services, is qualifying to do business in the state of Idaho and that it not required to engage a licensed engineer in the state of Idaho due to the work performed for aviation services. Your letter indicated that the Secretary of State has referred you to the Board for a letter of authorization.

The Board met recently and at this time, your company's request for a letter of authorization is herein denied.

In Idaho, the Board has been steadfast in refusing to agree to allow entities who do not employ Idaho licensed professional engineers to use the terms "engineer", "engineering", or "engineered" in its business name as registered with the Secretary of State. However, the Board always advises entities such as yours that it has no objection to your corporation doing business under a name that does not use such wording in its title. You may obtain a different DBA by contacting the Secretary of State.
