ARTICLE 1: NAME

The name of the corporation shall be Filipino-American Association of Idaho, Inc.

ARTICLE 2: PURPOSE

Fil-Am is organized primarily for cultural, educational, civic and charitable purposes, so as to qualify as a tax-exempt organization within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended from time to time, and non-profit organization under related provisions of Idaho state law. Fil-Am operations are conducted in accordance with applicable state and federal laws.

ARTICLE 3: ADDRESS

The street address of the registered office is 10037 Milclay Court, Boise, ID 83704 and the registered agent at such address is Irene Berntsen.

ARTICLE 4: BOARD OF DIRECTORS

All the management and affairs of the Corporation shall be under the direction of the Board of Directors, whose operations in governing the Corporation shall be defined by the statute and by the Corporation's Bylaws.

The Executive Councils, in accordance with the Corporation's Bylaws are authorized to exercise some or all of the powers, which would otherwise be exercised by a board. To the extent so authorized any such person or persons shall have the duties and responsibilities of the directors, and the directors shall be relieved to that extent from such duties and responsibilities.

The number of the Board of Directors constituting the initial Board of Directors shall be seven (7), and the names and addresses of the persons who are to serve as directors until their successors are elected and qualified are:

ARTICLE 6: MAILING ADDRESS

The official mailing address of the Corporation shall be P.O. Box 44904, Boise, Idaho 83711.

ARTICLE 7: MEMBERS

The Corporation consists of voting members. All registered members of good standing, as defined by Fil-Am's By-Laws, are qualified to vote on any matter for which voting is authorized or required under the terms of the Corporation's By-Laws.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in ARTICLE 2 hereof.

No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing and distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 8: DISTRIBUTION AND DISSOLUTION







In the event of the dissolution of the corporation, no member shall be entitled to any distribution or division of its remaining property or its process, and the balance of all money and property received by the Corporation from any source, after payment of all debts and obligations of the Corporation, shall be used for or distributed to another organization which meets the status and requirements of Section 501(c)(3) of the Internal Revenue Code of 1986 as the same now exists or as it may be amended from time to time, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE 9: BY-LAWS

Provisions for the regulation of the internal affairs of the Fil-Am shall be set forth in the By-Laws.
