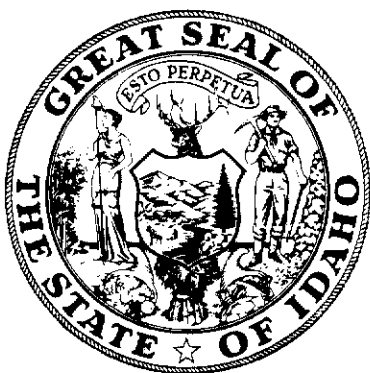

ARTICLES OF INCORPORATION

OF

JONES & JONES, INC.

The undersigned, acting as incorporators of JONES & JONES, INC., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is

JONES & JONES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

(A) To buy, sell, trade, manufacture, deal in and deal with goods, wares and merchandise of every kind and nature, and to carry on such business as wholesalers, retailers importers and exporters on its own account for others or under franchise agreements; to acquire all such merchandise, supplies, materials and other articles as shall be necessary or incidental to such business; to hold, acquire, mortgage, lease, and convey real and personal property in any part of the world, so far as necessary or expedient in conducting the business of the corporation; and to have any and all powers above set forth as fully as natural persons, whether as principals, agents, trustees or otherwise.

1 (B) To carry on any other kind of business or busi-
2 ness activities that the Board of Directors may from time to
3 time deem to be advisable or proper in connection with the
4 business.

5 (C) To purchase, lease, own, sell, mortgage, sublease,
6 and otherwise acquire lands, buildings, easements or property,
7 real and personal, which may be requisite for the purposes or
8 are capable of being conveniently used in connection with any
9 of the objects of this corporation, and to enter into, make,
10 perform and carry out contracts of every sort and kind with any
11 person, and to acquire and take over the good will, property,
12 rights, franchises and assets of every kind and the liabilities
13 of any person, firm, association, or corporation, either wholly
14 or in part, and to pay for the same in cash, stocks or bonds of
15 the corporation, or otherwise.

16 (D) To transact any and all lawful business for which
17 corporations may be incorporated under the Idaho Business Corpo-
18 ration Act.


