AMENDMENT TO ARTICLES OF INCORPORATION OF ELKHORN PROPERTY OWNERS ASSOCIATION, INC.

BE IT KNOWN, that we, the undersigned President and Secretary of Elkhorn Property Owners Association, Inc., do hereby certify in accordance with the provisions of Idaho Code §30-327, as follows:

- a. The name of the Corporation is Elkhorn Property Owners
 Association, Inc.
- b. The proposed Amendment will alter Article VII, SectionG, of the Articles of Incorporation as amended November 7, 1972.

The text of the Amendment shall read as follows:

- G. The mortgaging, encumbering, or other disposition of any property real or personal of the Corporation valued in excess of \$100,000.00, shall require the prior consent of at least fifty-one percent (51%) of the voting power of each class of the membership of the Corporation.
- c. The meeting at which the Amendment was adopted was held January 2, 1982, at 3:00 o'clock p.m. A quorum was present at the meeting and the Amendment received a majority of the votes which members present at such meeting in person or by proxy were entitled to cast.

Said meeting was an extension of the annual meeting of the Elkhorn Property Owners Association, Inc., originally called to order on December 30, 1981, but which was formally adjourned for lack of a quorum. The meeting was reconvened pursuant to Article VI, Section 6.03 C, of the Master Declaration of Covenants, Conditions, and Restrictions of Elkhorn at Sun Valley, which provides as follows:

"If any meeting cannot be held because a quorum is not present, the owners present either in person or by proxy may as otherwise provided by law adjourn the meeting to a time not less than forty-eight hours nor more than thirty days from the time the original meeting was called at which meeting the quorum requirements shall be the owners entitled to vote at least twenty-five percent of the total votes."
